NOTICE OF A PUBLIC HEARING BY THE LOS ANGELES COUNTY SECOND SUPERVISORIAL DISTRICT CONSOLIDATED OVERSIGHT BOARD FOR THE SUCCESSOR TO THE LYNWOOD REDEVELOPMENT AGENCY DIRECTING THE CITY OF LYNWOOD AS SUCCESSOR TO THE FORMER LYNWOOD REDEVELOPMENT AGENCY WITH RESPECT TO THE DISPOSITION PROCESS FOR ALL PARCELS OF REAL PROPERTY IDENTIFIED AS APNs 6193-003-902, -903, -904, & -905 AS PART OF ITS IMPLEMENTATION OF THE APPROVED LONG-RANGE PROPERTY MANGEMENT PLAN

NOTICE IS HEREBY GIVEN that on January 21, 2020 at the hour of 6:00 P.M., or as soon thereafter as the matter can be heard, the Los Angeles County Second Supervisorial District Consolidated Oversight Board for the Successor to the former Lynwood Redevelopment Agency will conduct a Public Hearing pursuant to California Street and Highway Code (CSHC) Sections 36524 and 36525 in the City of Inglewood City Council Chambers, One Manchester Boulevard, Ninth Floor, Inglewood, California, 90301. The public is invited to comment in the disposition process and requirements applicable to all parcels of real property identified as APN's 6193-003-902, -903, -904, & -905, as part of its implementation of the approved Long-Range Property Management Plan.

Proposed Action

PROPOSED DISPOSITION OF VACANT LAND PARCELS (APNs 6193-003-902, -903, -904, & -905) PURSUANT TO LONG-RANGE PROPERTY MANGEMENT PLAN - Successor Agency staff is requesting the Consolidated Oversight Board to direct the Successor Agency to dispose of all parcels identified as vacant land (APNs 6193-003-902, -903, -904, & -905) in the approved Long Range Property Management Plan. Said parcels are vacant landlocked land adjacent to a shopping center in the vicinity of Imperial Highway and Atlantic Boulevard in Lynwood, California 90262. More specifically described as four parcels totaling approximately 19,922 square feet abutting the westerly shopping center parking lot and a portion of Lot 14 of Tract 51 bearing said APNs 6193-003-902, -903, -904, & -905.

The Second Supervisorial District Consolidated Oversight Board will hold a public meeting to consider the adoption of a resolution directing the Successor Agency to dispose of said property identified in and pursuant to the Long-Range Property Management Plan, subject to disposition requirements, on Tuesday, January 21, 2020 commencing at 6:00 P.M., in the City of Inglewood City Council Chambers, One Manchester Boulevard, Ninth Floor, Inglewood, California, 90301. The public is invited to comment on the disposition process and requirements applicable to all parcels of real property identified as APN's 6193-003-902, -903, -904, & -905, as part of its implementation of the approved Long-Range Property Management Plan.
